This Privacy Policy outlines how we collect, use, disclose, and safeguard your personal data when you interact with us via our website, membership portal, events, or other services.

Types of Personal Data Collected

We may collect and process the following categories of personal data:

- Identity data: Full Name, NRIC / Passport Number, Date of Birth
- Contact data: Email Address, Phone Number, Mailing Address
- Professional data: Company Name, Job Title, Industry Affiliation
- Membership data: Membership Type, Application History, Participation in events
- Technical data: IP Address, Browser Type, Device Information, Cookies

Purpose of Collection

Your personal data is collected for the following purposes:

- To process membership applications and renewals
- To manage member profiles and provide member-exclusive content
- To send newsletters, updates, and event invitations
- To facilitate participation in competitions, workshops, and forums
- To comply with legal and regulatory obligations
